We have a 90 day extension to use the range at TVA thanks to Congressman Diane Black. Range will operate normally and have our regular matches through Feb 13<sup>th</sup>. As always safety is most important. Gate cards will be deactivated Feb 14th. Please return your TVA gate card after Feb 13<sup>th</sup> to the Club PO Box listed above. It is property of the US Government and we are to return them to TVA police in Knoxville.

\*\*\*\*\*No 50 BMG are allowed at the TVA range, per TVA effective Nov 17, 2016.

\*\*\*\*\*The Range at TVA will be closed Tuesday December 6<sup>th</sup>. TVA will have surveyors working in the area. Range will be open again Wednesday December 7<sup>th</sup>.

We have a contract on 135 acres on Hwy 231 for the new range. It is 3.25 miles north of Hwy 25. The following motions were voted on and passed November 14th and 15th 2016 to facilitate the purchase and construction of the new range.

1. Motion to purchase the above property for \$400,000 if closed within 6 months of the date of contract, or \$415,000 if closed after 6 months of the date of contract.
2. Motion for an assessment of \$150 for the current membership in addition to the \$50 annual dues for 2017. Total for current members is \$200. New members will pay a \$100 app fee and \$200 annual dues. Annual dues for 2018 and after will be \$200 until such time the club is financially solvent. We can then look at reducing the annual dues if the budget allows.
3. Motion to secure an approved bank loan for \$200,000 to assure we have enough to complete construction in a timely manner. To authorize William Legg, President to sign for the club. Members are not guaranteeing the loan, the land will stand for the loan.
4. Motion to rescind Article 7 sub paragraph G in the By-Laws which requires expenses over \$500 to be voted on at two meetings.
5. Motion to raise the membership cap to 1500.

The schedule is to have our drawings and required documents turned in to zoning in December. We can meet with the Board of Appeals the following month, January. We should be able to close on the loan in February, and begin construction in March. We hope to be able to start shooting at the range within 6 months of closing on the property. We are presently surveying for property lines and topo. We will start planning the range as soon as we have the site drawings finished. We are in the process of getting noise studies scheduled at the property lines as required by codes.

2017 Dues: if you have already paid \$50 send the \$150 assessment to the PO Box above.

If you have already paid \$50 for 2017 but do not wish to renew your membership at the new rates, you can get a \$50 refund. To get the refund you must send your 2017 membership card and TVA gate card to the PO Box by December 31, 2016.
